# Modification of Intake 5-Year B.A., LL.B. (Hons.) Programme Academic Year 2025-26

The Executive Council of the National Law School of India University ("the University") in its 103<sup>rd</sup> Meeting held on September 20, 2024 resolved to add 10 seats for Karnataka Students in the 5-Year B.A., LL.B. (Hons.) Programme of the University from the Academic Year 2025-26. These seats shall be allotted by the University based on the entrance examination merit list. This resolution was reviewed and confirmed by the General Council in its 38<sup>th</sup> Meeting held on September 20, 2024.

The University hereby notifies the addition of a further 10 seats in the 5-Year B.A., LL.B. (Hons.) Programme of NLSIU for "Karnataka Students" from Academic Year 2025-26. Candidates shall be selected as per the entrance examination merit list.

The CLAT 2025 Information Brochure for the Academic Year 2025-26 and the Admission Information published on the University website is hereby modified so that the total intake for the 5-Year B.A., LL.B. (Hons.) Programme of the University for the Academic Year 2025-26 shall be increased from 300 to 310.

All candidates claiming eligibility as Karnataka Students shall produce their Study Certificate/s issued by their School/s at the time of counselling/admission as set out below.

The total intake capacity shall be 310 (Three Hundred and Ten) seats for AY 2025-26 as set out below:

a) Eifteen (15) seats comprising 5% of the total intake shall be reserved horizontally for Persons with Disabilities (PWD).

b) Ninety (90) scats comprising 30% of the total intake shall be reserved horizontally for Women.

c) Seventy-five (75) seats comprising 25% of the total intake shall be reserved horizontally (compartmentalised) for Karnataka Students\*.

d) The ten (10) seats for Karnataka Students shall be allotted as per the entrance examination merit list.

e) All required certificates and supporting documents shall have to be submitted to the University at the time of counselling.

### \*Karnataka Students Category:

i. Candidates who have studied for not less than 10 years in a recognized educational institution in Karnataka shall be eligible to be considered as 'Karnataka Students?' Study certificates issued by duly recognised and affiliated educational institutions, which attest that the candidate has completed at least 10 years of schooling in Karnataka, shall have to be produced at the time of counselling.

ii. Candidates who have not completed ten years of study in Karnataka shall be eligible to apply under the Karnataka Students category if they fall under any of the below categories:

1. Children of defence personnel/ ex-servicemen, who at the time of joining service, have declared their hometown to be in the State of Karnataka, and who have served or are serving outside Karnataka, corresponding to the candidate's years of study outside Karnataka.

2. Children of employees of the Karnataka State Government who have served or are serving outside Karnataka corresponding to the candidate's years of study outside Karnataka.

3. Children of serving or retired employees belonging to the Karnataka cadre of the All India Services (IAS/IFS/IPS), who have served or are serving outside Karnataka corresponding to the candidate's years of study outside Karnataka.

4. Children of working or retired employees in the Central Armed Police Force service, who upon joining service declared their hometown to be in the State of Karnataka, and who have served or are serving outside Karnataka, corresponding to the candidate's years of study outside Karnataka.

**Illustration:** If the candidate has studied in Karnataka for three (3) years, they must prove that their parent/s were serving outside Karnataka for at least seven (7) years corresponding to their own period of study outside Karnataka.

If the candidate has not studied in Karnataka continuously for at least one (1) year, they must prove that their parent/s were serving outside Karnataka for at least ten (10) years corresponding to their own period of study outside Karnataka.

Eligible candidates must keep their Study Certificates issued by their School/s and other relevant documents ready to be submitted at the time of counselling.
